MARKET FROM JULY 23, 2014 TO SEPTEMBER 15, 2014**

WHEREAS, pursuant to the pertinent provisions of Section 21 of Republic Act 7160, otherwise known as the Local Government Code, the Local Government Unit of Tuguegarao is authorized to declare any closure of local roads falling within its jurisdiction;

WHEREAS, the Patronal Feast of Tuguegarao City dubbed as Pavyurulun “AFI” Festival is observed annually with the conduct of various socio-economic cultural activities;

WHEREAS, among the activities to be undertaken in the said celebration is the holding of the traditional “Baratillo” Flea Market.




On motion of all members present, **CITY RESOLUTION NO. 078-2014** was **UNANIMOUSLY APPROVED**.
