**WHEREAS**, the Committee on Finance and Appropriation reviewed the Annual Budget of Barangay Centro 02 for CY 2014;

**WHEREAS**, the Annual Budget of Barangay Centro 02 for CY 2014 has complied with the established budgetary requirements as certified by the City Budget Officer and same was validated by the Committee on Finance and Appropriation;

**RESOLVED FURTHER**, that all disbursements shall be in accordance with prescribed guidelines, subject to the usual accounting and auditing rules and regulations.


