CITY RESOLUTION NO. 084-2014

A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. JEFFERSON P. SORIANO, TO TEMPORARILY CLOSE THE ENRILE BOULEVARD STREET, CARIG, TUGUEGARAO CITY FROM AUGUST 8-11, 2014 FOR THE PAVVURULUN “AFI” FESTIVAL 2014 AND TO ALLOW TRAFFIC AS THE NEED ARISES DURING THE AFOREMENTIONED DAYS

WHEREAS, pursuant to Section 21 of Republic Act 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit of Tuguegarao is authorized to declare any closure of local roads falling within its jurisdiction;

WHEREAS, Tuguegarao City shall be celebrating its Patronal Feast dubbed as Pavvurulun “AFI” Festival on August 8-16, 2014;

WHEREAS, in celebration of the Pavvurulun “AFI” Festival, there shall be various socio-economic cultural activities to be held at the Enrile Boulevard Street, Carig, Tuguegarao City;

WHEREAS, the City Mayor, Hon. Jefferson P. Soriano, sought an authority from the Council for the temporary closure of Enrile Boulevard Street for the conduct of the said activities on August 8-11, 2014.

NOW THEREFORE RESOLVE, as it is hereby **RESOLVED**, to authorize the City Mayor, Hon. Jefferson P. Soriano to temporarily close the Enrile Boulevard Street, Carig, Tuguegarao City from August 8-11, 2014 for the Pavvurulun “AFI” Festival 2014 and to allow traffic as the need arises during aforementioned days.

RESOLVED FURTHER, that copies of this Resolution be forwarded to the Office of the City Mayor, Tuguegarao City Police Station, Public Safety and Security Office and City Engineering Office for the signages and widest dissemination.
