CITY RESOLUTION NO. 089-2014

A RESOLUTION CREATING THE FLOOD MITIGATION COMMITTEE (FMC)
FOR THE CAGAYAN RIVER COMPONENT OF THE FLOOD RISK MANAGEMENT PROJECT
(FRIMP) OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH)
AND DESIGNATING THE FMC STANDING MEMBERS
FROM THE TUGUEGARAO CITY GOVERNMENT

WHEREAS, the Flood Risk Management Project (FRIMP) aims to mitigate flood damage in selected core areas in Cagayan River, by implementing structural and non-structural measures against flood and thereby contributing to the sustainable and stable economic development and climate change adaption in the target areas;

WHEREAS, the City Government of Tuguegarao, the Municipal Government of Enrile and the Department of Public Works and Highways (DPWH) have entered into a Memorandum of Agreement on December 22, 2010 for the implementation of the Cagayan River Flood Control Project, as one of the sub-projects in FRIMP along the Selected Principal Rivers;

WHEREAS, one of the provisions of the said Memorandum of Agreement is the creation of the Flood Mitigation Committee by the Tuguegarao City Government and the Municipal Government of Enrile that will perform the following activities: (1) coordinate in handling issues related to Project implementation, operation and maintenance (O&M) activities of the flood mitigation structures, controlling land encroachment and disorderly land development within the river boundary, joint inspection and evaluation on the magnitude of any damage caused by disaster and recommendation to the concerned agencies on the appropriate repair and rehabilitation activities to be undertaken, and other matters related to the Project; (2) enhance/strengthen the publicity and awareness of the Project; (3) coordinate, facilitate and assist in activities on the resettlement and acquisition of right-of-way (ROW); (4) execute and sustain non-structural measures; (5) monitor the O&M activities; (6) monitor illegal activities within the river boundary; (7) set-up a query window; and, (8) act as grievance and redress committee for ROW and other matter;





WHEREAS, the Flood Mitigation Committee (FMC) shall be chaired by DPWH and co-chaired by LGU in pre-construction and construction stages of the Project and by LGU and co-chaired by DPWH during its post-construction stage (O&M) and shall be composed of standing members initially from the Engineering Office, Planning and Development Office and Disaster Risk Reduction and Management Office of the LGUs of Tuguegarao City and Municipality of Enrile as well as from the DPWH Cagayan 3rd Engineering Office.

NOW THEREFORE,

RESOLVED, as it is hereby **RESOLVED**, to approve the creation of the Flood Mitigation Committee (FMC) for the Cagayan River Component of the Flood Risk Management Project (FRIMP) of the Department of Public Works and Highways (DPWH) and designating the City Engineer, the City Planning and Development Officer and the City Risk Reduction and Management Officer as initial FMC standing members from the Tuguegarao City Government.

RESOLVED FURTHER, to furnish certified copies of this Resolution to Patrick B. Gatan, CESO III, Project Director, Unified Project Management Office-Flood Control Management Cluster, NCR Compound, 2nd Street, Port Area, Manila.
