CITY RESOLUTION NO. 120-2014

A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ENGELBERT C. CARONAN, JR., TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE INTEGRATED FARMERS COOPERATIVE AND APPROVING THE SAME FOR THE USE OF THE THIRTY (30) HECTARE PASTURELAND/GRAZING LAND PORTION OF THE TREE/ECO-TOURISM PARK AT NAMABBALAN SUR FOR FORAGE PRODUCTION AND THE ESTABLISHMENT OF OTHER DAIRY PRODUCTIONS IN THE AREA

WHEREAS, the Department of Environment and Natural Resources (DENR) through the Community Environment Resources Office has offered sixty three (63) hectare forestland located at Namabbalan Sur to LGU-Tuguegarao City under joint protection, development and management scheme for 25 years;

WHEREAS, a letter from the Office of the City Mayor requesting for a Resolution granting permission for the Integrated Farmers Cooperative to utilize thirty (30) hectare pastureland/grazing land for forage production and establishment of other dairy productions in the area was submitted to the Sixth City Council on June 02, 2014;

WHEREAS, City Resolution No. 130-2010 was enacted approving the Memorandum of Agreement between the DENR and LGU-Tuguegarao City for the joint protection, development and management of the said 63 hectare forestland at Namabbalan Sur, Tuguegarao City;


WHEREAS, the Integrated Farmers Cooperative, a registered organization duly organized and existing under and by virtue of the laws of the Republic of the Philippines, is identified as beneficiary of the Philippine Rural Development Project funded by World Bank.

NOW THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to allow the Integrated Farmers Cooperative to utilize thirty (30) hectare pastureland/grazing land portion of the forestland for forage production and establishment of other dairy productions in the area within the period of twenty (20) years as per the Memorandum of Agreement.

RESOLVED FURTHER, to authorize the City Mayor, Hon. Engelbert C. Caronan, Jr., to sign for and in behalf of the Tuguegarao City Government the Memorandum of Agreement with the Integrated Farmers Cooperative, represented by its President for the use of the thirty (30) hectare pastureland/grazing land portion of the forestland for forage productions and for the establishment of other dairy productions in the area.

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY WHOM THESE PRESENTS:

This Memorandum of Agreement is made and entered into by and between:

The **TUGUEGARAO CITY GOVERNMENT , CAGAYAN** represented by by its City Mayor, HON. ENGELBERT C. CARONAN, with postal address at the Regional Government Center, Carig Sur, Tuguegarao City, hereinafter referred to as “ **FIRST PARTY** ”

-and-

The **INTEGRATED FARMERS COOPERATIVE (IFC)** represented by its President, Mr. Sherwin Buguina, with postal address at Namabbalan Sur ,Tuguegarao City, Cagayan hereinafter referred to as “ **SECOND PARTY** ”;

WITNESSETH

WHEREAS, the Philippine Rural Development Project (PRDP) is a 6-year national government platform which envisions to enhance the Agriculture and Fishery Modernization Plan (AFMP) and contribute to achieving the national goals of inclusive growth, job creation and poverty reduction;

WHEREAS, the IFC, a registered cooperative duly organized and existing under and by virtue of laws of the Republic of the Philippines, has been identified as a proponent group and beneficiary of the PRDP as a result of series of evaluations conducted by concerned instrumentalities from regional to national level;

WHEREAS, by virtue of City Resolution No. 120-2014, the Tuguegarao City-LGU granted to IFC thirty (30) hectares of pastureland/grazing land at Namabbalan Sur, Tuguegarao City, Cagayan for forage production and establishment of other dairy productions in the area;

A. General Obligations

1. Review and approve annual work plans and oversee the implementation of the indicative plan.
2. Create a joint LGU-IFC Team which shall also protect the area against the squatters, intruders and “Kaingeneros” and shall have the authority to institute appropriate action(s) against the latter.
3. Conduct a quarterly meeting to thresh out issues and problems and to institute appropriate technology and other measures for the success of the project.
4. Prepare a development report on the progress of the implementation of the project.
