**A RESOLUTION AUTHORIZING THE CITY MAYOR,  
HON. ATTY. ENGELBERT C. CARONAN, JR., TO SIGN FOR AND IN BEHALF OF THE  
TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE  
DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES ON THE  
IMPLEMENTATION OF THE GRASSROOTS PARTICIPATORY BUDGETING**

**WHEREAS**, the Office of the President of the Philippines issued Executive Order No. 26 on February 24, 2011 ordering and declaring the implementation of a National Greening Program (NGP) as a government priority and designating the Department of Environment and Natural Resources as the lead agency;

**WHEREAS**, National Budget Memorandum No. 121 provides the guidelines for the implementation and monitoring of FY 2013 and FY 2014 Grassroots Participatory Budgeting, formerly called Bottom-up Budgeting;

**WHEREAS**, LGU Tuguegarao City signified its interest to participate in the National Greening Program;

**NOW THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to authorize the City Mayor, Hon. Atty. Engelbert C. Caronan, Jr., to sign for and in behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Environment and Natural Resources, represented by its Regional Director, Hon. Benjamin T. Tumaliuan, on the implementation of the grassroots participatory budgeting.
