**CITY RESOLUTION NO. 123-2014**

**A RESOLUTION AUTHORIZING THE CITY MAYOR,  
HON. ATTY. ENGELBERT C. CARONAN, JR., TO SIGN FOR AND IN BEHALF OF THE  
TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE  
DEPARTMENT OF HEALTH FOR THE IMPLEMENTATION OF THE  
CY 2014 HEALTH FACILITIES ENHANCEMENT PROGRAM**

**WHEREAS**, the 16<sup>th</sup> Congress appropriated the amount of Php355,110,000.00 under Republic Act 10633 known as the General Appropriations Act of 2014;

**WHEREAS**, the Department of Health through the Office of the Secretary issued Department Order No. 2014-0071 dated April 14, 2014 regarding the Guidelines for the Release and Utilization of Funds to Cover Health Facilities Enhancement Program/Projects to Regional Offices for allocation to different LGUs;

**WHEREAS**, the amount of Two Million Five Hundred Thousand Pesos (P2,500,000.00) is allocated to Tuguegarao City Government for the completion of the City Health Office;

**WHEREAS**, the actual fund to be released to the Tuguegarao City Government will be based on the bidded cost as a result of the public bidding conducted;

**WHEREAS**, Tuguegarao City Government is willing to assist the Department of Health (DOH) on the implementation of the project;

**WHEREAS**, the Tuguegarao City Government has the capacity and ability to implement the said project as signified in their letter-request to undertake the project by administration;


**WHEREAS**, the Tuguegarao City Government has submitted their previous liquidation report of the transferred expenditures and cleared of financial obligations.

**NOW THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to authorize the City Mayor, Hon. Atty. Engelbert C. Caronan, Jr., to sign for and in behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Health Regional Office No. 02, represented by its Director IV, Rio L. Magpantay, M. D., PHSAE, CESO III, for the implementation of CY 2014 Health Facilities Enhancement Program.
