WHEREAS, the 16th Congress appropriated the amount of Php355,110,000.00 under Republic Act 10633 known as the General Appropriations Act of 2014;

WHEREAS, the Department of Health through the Office of the Secretary issued Department Order No. 2014-0071 dated April 14, 2014 regarding the Guidelines for the Release and Utilization of Funds to Cover Health Facilities Enhancement Program/Projects to Regional Offices for allocation to different LGUs;

WHEREAS, the amount of Two Million Five Hundred Thousand Pesos (P2,500,000.00) is allocated to Tuguegarao City Government for the completion of the City Health Office;

WHEREAS, the actual fund to be released to the Tuguegarao City Government will be based on the bidded cost as a result of the public bidding conducted;

WHEREAS, Tuguegarao City Government is willing to assist the Department of Health (DOH) on the implementation of the project;

WHEREAS, the Tuguegarao City Government has the capacity and ability to implement the said project as signified in their letter-request to undertake the project by administration;

WHEREAS, the Tuguegarao City Government has submitted their previous liquidation report of the transferred expenditures and cleared of financial obligations.
