WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS
ON LAMP POSTS/STREETLAMPS PROJECT**

WHEREAS, the Department of Public Works and Highways is tasked to undertake the installation of lamp posts/streetlamps along selected areas in the city;

WHEREAS, the Tuguegarao City Government has agreed to accept the Project and commits to secure and undertake the maintenance thereof, including payment of corresponding electric bills and other related expenses;

WHEREAS, the Department of Public Works and Highways and the Tuguegarao City Government agreed to execute a Memorandum of Agreement subject to the terms and conditions stipulated therein;

WHEREAS, the parties represent that they have the requisite power, authority and capacity to enter into an agreement and perform their obligations as stipulated in the Memorandum of Agreement;

WHEREAS, all disbursements shall be in accordance with auditing rules and regulations.


