**CITY RESOLUTION NO. 154-2014**

**A RESOLUTION GRANTING ACCREDITATION TO THE PHILIPPINE CHAMBER  
OF COMMERCE AND INDUSTRY, CAGAYAN CHAPTER AS A  
NON-GOVERNMENT ORGANIZATION PURSUANT TO THE PROVISIONS  
OF THE LOCAL GOVERNMENT CODE OF 1991 AND  
DILG MEMORANDUM CIRCULAR NO. 2007-81 DATED JULY 17, 2007**

**WHEREAS**, the Sixth City Council through the Committee on Laws, Ordinances, Revisions and Legal Matters reviewed and deliberated on the merits of the application for accreditation of the Philippine Chamber of Commerce and Industry (PCCI), Cagayan Chapter, a non-government organization based in Tuguegarao pursuant to the Local Government Code of 1991 and DILG Memorandum Circular No. 2007-81 dated July 17, 2007;

**WHEREAS**, the Committee found the application for accreditation of the PCCI, Cagayan Chapter with the necessary supporting documents to have complied with the requirements laid down by the Memorandum Circular and other standards set by the City Council.

**NOW, THEREFORE**, for and in consideration of the foregoing premises,

**RESOLVE**, as it is hereby **RESOLVED**, to grant accreditation to the Philippine Chamber of Commerce and Industry (PCCI), Cagayan Chapter as an non-government organization (NGO) entitled to the prerogatives and privileges as provided by the Local Government Code of 1991 and DILG Memorandum Circular No. 2007-81.

**RESOLVED FURTHER**, to direct the above-mentioned organization to submit its audited financial statements to the Sangguniang Panlungsod to form part of their individual records.

**RESOLVED FINALLY**, that this Resolution be forwarded to the Office of the City Mayor, Hon. Atty. Engelbert C. Caronan, Jr., City Planning and Development Coordinating Office and to the above accredited NGO for their information and guidance.
