CITY RESOLUTION NO. 163-2014

A RESOLUTION AMENDING CITY RESOLUTION NO. 072-2014 APPROVING THE MEMORANDUM OF AGREEMENT AND AUTHORIZING THE HONORABLE CITY MAYOR, ATTY. ENGELBERT C. CARONAN, JR., TO SIGN FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS REGARDING THE IMPLEMENTATION OF SPECIAL LOCAL ROAD FUND (SLRF) UNDER REPUBLIC ACT 8794

WHEREAS, Section 1 of Republic Act No. 8794, otherwise known as the “Motor Vehicles User’s Charge Law (MVUC)”, provides that the State shall provide and ensure the adequate maintenance of national and provincial roads through sufficient funding for the purpose;

WHEREAS, Section 7 of the same law provides that “all monies collected under the said Act shall be earmarked solely and exclusively used for the road maintenance and improvement of road drainage, installation of adequate and efficient traffic lights and road safety devices and air pollution control measures”;

WHEREAS, five percent (5%) of all monies collected shall be deposited in the National Treasury under the Special Local Road Fund (SLRF) which shall be apportioned to provincial and city governments in accordance with the vehicle population and size of the road network under their respective jurisdiction and shall be used exclusively for the maintenance of roads, traffic management and road safety devices;

WHEREAS, pursuant to Section 3 and Section 5 of Executive Order No. 124 dated January 1987, the Department of Public Works and Highways (DPWH) shall decentralize its responsibilities to the fullest extent possible;

WHEREAS, the fund shall be implemented by Tuguegarao City Government based on the Program of Work prepared by the City Engineering Office and approved by the DPWH;


WHEREAS, it is necessary that the Memorandum of Agreement should be entered into for the purpose of delineating responsibilities over the implementation of policies, standards and procedures at the LGU level in accordance with the pertinent provisions of SLRF under the MUVCLaw and its Implementing Rules and Regulations.

NOW THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to amend City Resolution No. 072-2014 approving the Memorandum of Agreement and authorizing the Honorable City Mayor, Atty. Engelbert C. Caronan, Jr., to sign for and in behalf of Tuguegarao City Government the Memorandum of Agreement with the Department of Public Works and Highways, Regional Office No. 02 regarding the implementation and utilization of the Special Local Road Fund (SLRF) extended by the Department of Interior and Local Government (DILG).

On motion of Hon. Noel A. Mora, duly seconded by Hon. Perla C. Tumaliuan, **CITY RESOLUTION NO. 163-2014** was **UNANIMOUSLY APPROVED**.
