**A RESOLUTION APPROVING LOCAL POVERTY REDUCTION ACTION TEAM (LPRAT)
RESOLUTION NO. 02-2014 ON THE REPLACEMENT OF PROGRAM FOR
STREET CHILDREN TO REPAIR OF CLASSROOM UNDER
THE GPB/BuB 2014 OF TUGUEGARAO CITY**

WHEREAS, in pursuit of attaining the Philippine Development Plan's goal of inclusive growth and poverty reduction, and promoting good governance at the local level, the Human Development and Poverty Reduction Cluster (HDPRC) through the Grassroots Budgeting Oversight Agencies shall implement the Grassroots Participatory Budgeting (GPB), formerly called Bottom-up Budgeting, to ensure the implementation of priority poverty reduction projects as identified at the city/municipal level through a participatory planning and budgeting process;

WHEREAS, the Local Poverty Reduction Action Plan of Tuguegarao City embodies the programs and projects collectively drawn through a participatory process by the LGU with Civil Society Organizations (CSOs) and other stakeholders to address the needs of the poor constituencies and the marginalized sectors in the city;

WHEREAS, the Department of Education (DepEd) has a menu of programs/projects and activities;

WHEREAS, the identified Program for Street Children under the GPB/BuB 2014 is not provided in the menu of programs of DepEd;

WHEREAS, the repair of classroom located at Northeast Central School is a priority recommendation by the Division Office of Tuguegarao City and the CSOs of Tuguegarao City as a replacement of the Program for Street Children;

WHEREAS, the Local Poverty Reduction Action Team has passed Resolution No. 02, series of 2014 titled "A Resolution for the Replacement of Program for Street Children to Repair of Classroom

under the GPB/BuB 2014 of Tuguegarao City” which was indorsed by the City Mayor, Atty. Engelbert C. Caronan, Jr. to the Sixth City Council;

WHEREAS, the requirements submitted by LPRAT, City Engineer and Division Office were studied and reviewed by the Committees concerned and were found to be in order.
