## **CITY RESOLUTION NO. 179-2014**

A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ENGELBERT C. CARONAN, JR., TO ENTER INTO A CONTRACT OF LEASE WITH MS. LINDA UY, OWNER OF THE LOT WHERE THE AFFECTED VENDORS SHALL BE TEMPORARILY RELOCATED, FOR THE UPGRADING/IMPROVEMENT AND EXPANSION OF THE DON DOMINGO PUBLIC MARKET

**WHEREAS**, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, has empowered the City Government to implement laws in the administration, operation, maintenance and regulation of public markets;

WHEREAS, the City Mayor, Hon. Engelbert C. Caronan, Jr., indorsed the letter request of Ms. Charesma Joy T. Pascual, proprietor of CJT Pascual Construction, to the Sixth City Council dated November 04, 2014 to relocate the vendors in their rented lot to start the upgrading/improvement and expansion of the Don Domingo Public Market and to collect rentals based on the area of occupancy;

WHEREAS, the committees which deliberated on the matter found the necessity of granting the request for authority to relocate the vendors to the lot owned by Ms. Linda Uy to start the upgrading/improvement and expansion of the Don Domingo Public Market;

WHEREAS, there is a necessity for the City Government to enter into a Contract of Lease with Ms. Linda Uy, the owner of the lot where the affected vendors shall be relocated starting January 1, 2015.

**NOW THEREFORE, RESOLVE,** as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Atty. Engelbert C. Caronan, Jr., to enter into a Contract of Lease with Ms. Linda Uy, owner of the lot where the affected vendors shall be temporarily relocated, for the upgrading/improvement and expansion of the Don Domingo Public Market.
