**CITY RESOLUTION NO. 180-2014**

**A RESOLUTION GRANTING AUTHORITY TO THE CITY TREASURER,  
MR. BUENAVENTURA F. LAGUNDI, TO COLLECT RENTAL FEES FROM  
THE AFFECTED VENDORS OF THE UPGRADING/IMPROVEMENT AND EXPANSION  
OF THE DON DOMINGO PUBLIC MARKET BASED ON THEIR AREA OF  
OCCUPANCY PURSUANT TO MARKET CODE OF 2005**

**WHEREAS**, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, has empowered the City Government to implement laws in the administration, operation, maintenance and regulation of public markets;

**WHEREAS**, the City Mayor, Hon. Engelbert C. Caronan, Jr., indorsed the letter request of Ms. Charesma Joy T. Pascual, proprietor of CJT Pascual Construction, to the Sixth City Council dated November 04, 2014 to relocate the vendors in their rented lot to start the upgrading/improvement and expansion of the Don Domingo Public Market;

**WHEREAS**, there is a necessity to relocate the affected vendors to the lot owned by Ms. Linda Uy for them to continue with their business;

**WHEREAS**, once the vendors are already relocated in their new location, there is a necessity for the City Treasurer, Mr. Buenaventura F. Lagundi, to collect rental fees based on their area of occupancy pursuant to Market Code of 2005.

**NOW THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to grant authority to the City Treasurer, Mr. Buenaventura F. Lagundi, to collect rental fees from the affected vendors of the upgrading/improvement and expansion of the Don Domingo Public Market.
