**A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR,  
HON. ATTY. ENGELBERT C. CARONAN, JR., FOR THE TEMPORARY CLOSURE  
OF CORNER OF BLUMENTRITT AND AGUINALDO STREETS TO THE CORNER  
OF OTIS AND AGUINALDO STREETS, INCLUDING A PORTION OF RIZAL STREET  
IN FRONT OF RIZAL'S PARK AND TUGUEGARAO EAST CENTRAL SCHOOL, FOR  
THE UKAY-UKAY GROUP VENDORS TO DISPLAY THEIR GOODS  
(USED CLOTHES) AT 7:00 P.M. TO 5:30 A.M. THE FOLLOWING DAY  
UPON APPROVAL OF THIS RESOLUTION UNTIL JANUARY 04, 2015**

**WHEREAS**, pursuant to the pertinent provisions of Section 21 of Republic Act 7160, otherwise known as the Local Government Code, the Local Government Unit of Tuguegarao is authorized to declare any closure of local roads falling within its jurisdiction;

**WHEREAS**, the City Mayor, Hon. Engelbert C. Caronan, Jr., endorsed the letter request of Mr. Ricardo C. Bingcang, Acting President of Starmall, Ukay-Ukay Group Vendors, asking permission to allow them to display their goods (used clothes) at 7:00 P.M. to 5:30 A.M. the following day upon approval of this resolution until January 4, 2015;



**WHEREAS**, the said indorsement was referred to the Committee on Market and Slaughter, Committee on Ways and Means, and Committee on Public Order, Safety and Disaster Preparedness on December 09, 2014;

**WHEREAS**, the joint committees held a committee meeting with the Starmall Acting President, Mr. Ricardo C. Bingcang, and some members of the Ukay-Ukay Group Vendors on December 14, 2014 at the Barangay Gymnasium, Balzain-East (Centro 11), Tuguegarao City;

**WHEREAS**, in the spirit of Christmas Season and finding the request beneficial to the City Government, the joint committees recommended for the approval of the request allowing the Ukay-Ukay Group Vendors to conduct night market starting at 7:00 P.M. to 5:30 A.M. the following day upon approval of this resolution until January 4, 2015;

**WHEREAS**, each vendor is entitled of only one space, containing an area of 2m x 3m;

**WHEREAS**, the corresponding fees to be imposed shall be P10.00 per square meter of the area occupied pursuant to the Market Code of 2005.


**NOW THEREFORE, RESOLVED** as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Engelbert C. Caronan, Jr., for the temporary closure of the corner of Blumentritt and Aguinaldo Streets to the corner of Otis and Aguinaldo Streets, including a portion of Rizal Street in front of Rizal's Park and Tuguegarao East Central School, for the Ukay-Ukay Group Vendors to display their goods (used clothes) at 7:00 P.M. to 5:30 A.M. the following day upon approval of this resolution until January 4, 2015.

**RESOLVED FURTHER**, that a copy of this resolution be forwarded to the Office of the City Mayor, City Treasurer's Office, Office of the Market Administrator, Tuguegarao City Police Station, Office of the City Fire Marshall and the Public Safety and Security Office for their information and implementation.
