AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 01 OF TUGUEGARAO CITY FOR CY 2015

WHEREAS, Section 458 of Republic Act 7160, otherwise known as the Local Government Code of 1991, and Article 99 (2) (i) of the Rules and Regulations Implementing the Local Government Code of 1991 provides that the Sangguniang Panlungsod has the power to "approve annual and supplemental budgets of the City Government and appropriate funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law, in order to promote the general welfare of the city and its inhabitants";

WHEREAS, the City Mayor, Hon. Jefferson P. Soriano, has endorsed a request for an Appropriation Ordinance through a Supplemental Budget in the amount of Seventy Three Million Seven Hundred Seven Thousand Two Hundred Eighty Pesos (P73,707,280.00) to fund Personal Services and Capital Outlay;

WHEREAS, the Local Finance Committee submitted a certification as to the availability of funds from the Excess of the Retained Earnings for Calendar Year 2014 in the amount of Seventy Three Million Seven Hundred Seven Thousand Two Hundred Eighty Pesos (P73,707,280.00) which is free from any obligation and is available for appropriation;

NOW, THEREFORE, be it ordained in session assembled by the Sixth City Council to enact:

SECTION 1. AUTHORIZATION. The General Fund Supplemental Budget No. 01 of Tuguegarao City for Calendar Year 2015 with a total appropriation of Seventy Three Million Seven Hundred Seven Thousand Two Hundred Eighty Pesos (P73,707,280.00) is hereby authorized to finance the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay.

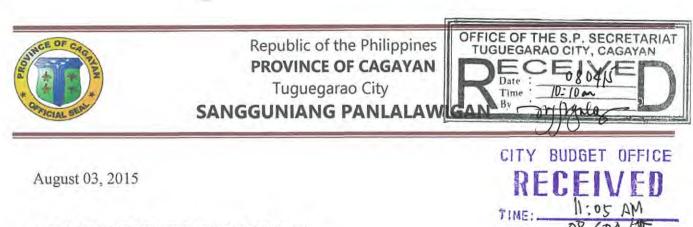

COMMITTEE REPORT

SUBJECT:

CY 2015 SUPPLEMENTAL BUDGET NO. 01 OF TUGUEGARAO CITY, approved under Appropriation Ordinances No. 02 - 2015, of the Sangguiang Panlungsod of the said City

FINDINGS/OBSERVATIONS:

The Local Government Code of 1991, or Republic Act No. 7160, particularly Section 327, is herein-quoted below:

"The sangguniang panlalawigan shall review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities in the same manner and within the same period prescribed for the review of other ordinances."

Pursuant to the law therefore, appropriation ordinances, in the form of annual or supplemental budgets emanating from the lower sanggunian/s concerned (Sangguniang Panlungsod of the City of Tuguegarao, and the different Sangguniang Bayan of the municipalities within the Province) are submitted for the review of the higher Sanggunian (Sangguniang Panlalawigan of Cagayan) of the Province.

The Committee on Finance and Appropriation which is a regular committee of the Sangguniang Panlalawigan is tasked, among others, to evaluate the validity of these appropriation ordinances and submits its recommendations thereon to the Sangguniang Panlalawigan in plenary.

In the case before Us, the CY 2015 Supplemental Budget No. 01 of Tuguegarao City as embodied in the respective appropriation ordinances of the lower Sanggunians concerned, are submitted for the review of the Sangguniang Panlalawigan of Cagayan.

As a matter of procedure, however, these annual or supplemental budget appropriations are referred to the Provincial Finance Committee (PFC) for its initial findings, comment and recommendation.

The herein Committee takes note of the findings of the PFC that the subject appropriation ordinances have shown substantial compliance with the provisions of the Code (Local Government Code of 1991) and its implementing rules and regulations, subject however to the compliance with the restrictions, limitations and conditions provided under existing rules and regulations on the matter as set forth in the said reports, with the corresponding recommendations for their respective favorable review.

A committee hearing was conducted on July 21, 2015 to discuss on the issue on whether or not the designation of Mr. Marcelino Gumabay as the Secretariat of the City Development Council is valid. The chairperson of the

Upon presentment of the Memorandum Order 50 series 2015 dated, May 14, 2015, designating Mr. Marceliono Gumabay as the Secretariat of the City Development Council, this Committee opined that Mr. Gumabay has the authority to act and sign documents relative to passage and approval of resolutions of the CDC.

On a final note, the herein Committee upon a careful evaluation on the basis in the findings relied upon by the Provincial Finance Committee as stated in its respective reports and recommendation, therefore stamps its approval on the above-mentioned appropriation ordinances, respectively.

RECOMMENDATION:

IN VIEW OF THE FOREGOING, this Committee respectfully recommends for the passage of separate Resolutions approving the CY 2015 Supplemental Budget No. 01 of Tuguegarao City, subject to the compliance with the conditions, restrictions, and limitations imposed under existing rules and regulations on the matter as set forth in the Report of the Provincial Finance Committee, as attached and made an integral part hereof.

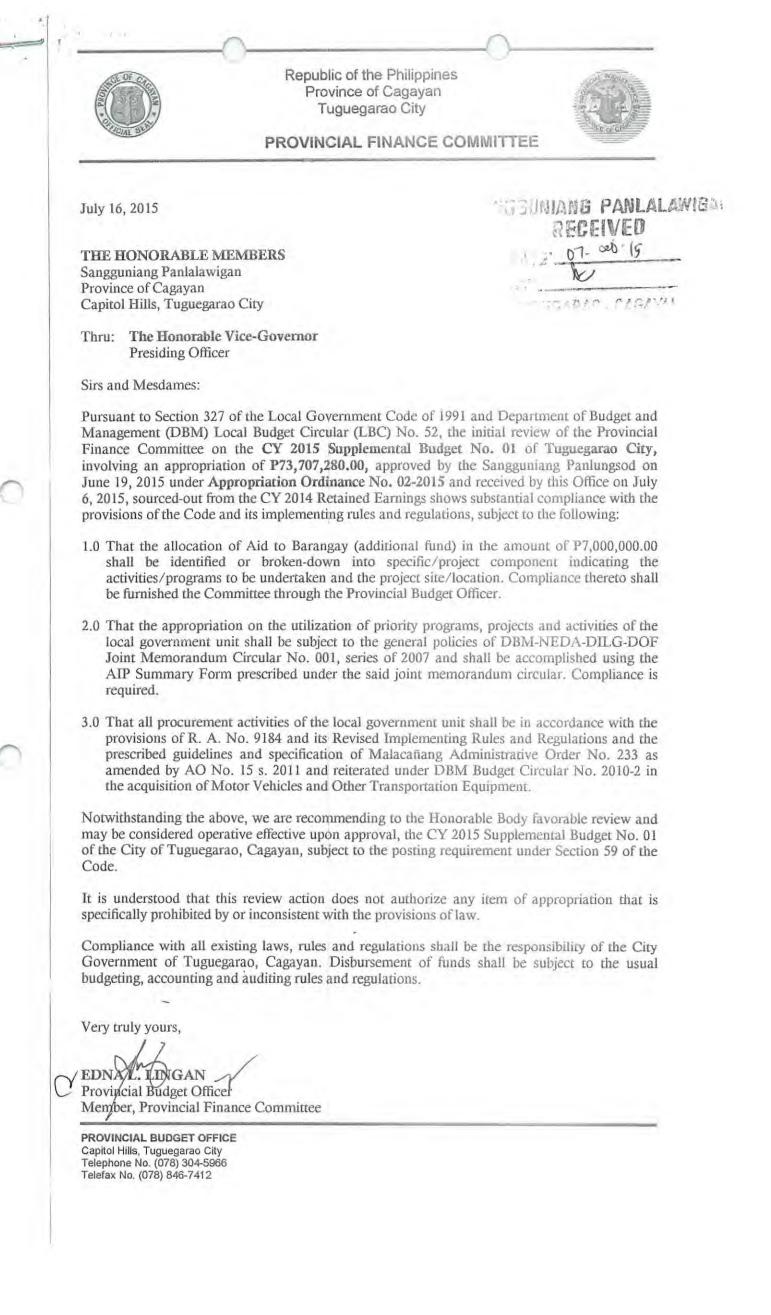
