WHEREAS, Section 458 (I) (viii) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the Sangguniang Panlungsod has the power to determine the positions and corresponding compensation and benefits of officials and employees;

WHEREAS, in the exigency of service, in order to promote efficiency and institute an effective workforce, there is a need to create additional positions and provide funds thereof for the City Agriculture Office of Tuguegarao City;

NOW, THEREFORE, be it **ORDAINED** by the Sixth City Council in session assembled to enact:



SECTION 1. TITLE. This Ordinance shall be known as “*Ordinance Creating Additional Positions for the City Agriculture Office of Tuguegarao City and Providing Funds Thereof.*”

SECTION 2. The following positions for the City Agriculture Office of Tuguegarao City are hereby authorized and created:

- One (1) position for Administrative Aide IV (Reproduction Machine Operator II), SG 4; and,
- One (1) position for Administrative Aide I (Utility Worker I), SG 1

SECTION 3. FUNDING FOR THE NEW POSITIONS. The corresponding funds for the salaries and benefits for the aforementioned positions shall be provided in the Annual Budget and Supplemental Budget of Tuguegarao City.

SECTION 4. The filling up of these new positions shall be subject to the Personal Services Limitation (PS Limitation) provision of Section 325 (a) RA 7160 or the Local Government Code of 1991 and pertinent Civil Service Rules and Regulations.

SECTION 5. SEPARABILITY CLAUSE. If any part of this Ordinance is declared invalid or unlawful by law or issuances, the other parts not affected thereby shall remain in full force and effect.

SECTION 6. EFFECTIVITY. This Ordinance shall take effect upon its approval.


