**SECTION 1. TITLE.** This Ordinance shall be known as "Ordinance Creating Additional Positions for the City Budget Office of Tuguegarao City and Providing Funds Thereof."

**SECTION 3. FUNDING FOR THE NEW POSITION.** The corresponding funds for the salary and benefits for the aforementioned position shall be provided in the Annual Budget and Supplemental Budget of Tuguegarao City.

**SECTION 4.** The filling up of the new position shall be subject to the Personal Services Limitation (PS Limitation) provision of Section 325 (a) RA 7160 or the Local Government Code of 1991 and pertinent Civil Service Rules and Regulations.

**SECTION 5. SEPARABILITY CLAUSE.** If any part of this Ordinance is declared invalid or unlawful by law or issuances, the other parts not affected thereby shall remain in full force and effect.

SECTION 6. EFFECTIVITY. This Ordinance shall take effect upon its approval.
