
**Madam:**

**AN ORDINANCE AMENDING SECTION 12 OF CITY ORDINANCE NO. 04-2004 – “THE  
TUGUEGARAO CITY INVESTMENTS AND INCENTIVES CODE OF 2014”**

**WHEREAS**, the positions indicated in Section 12 of the Investments and Incentives Code of 2014 are not covered by the Local Budget Circular, otherwise known as LBC 61 issued by the Department of Budget and Management;

**WHEREAS**, Local Budget Circular, otherwise known as LBC 61, addressed to all Local Chief Executives, with the subject REVISED INDEX OF OCCUPATIONAL SERVICES, POSITION TITLES AND SALARY GRADES (IOS) IN THE LOCAL GOVERNMENT, embodies the following positions:

One (1) Development Management Officer IV  
One (1) Development Management Officer II

One (1) Economic Researcher  
 One (1) Administrative Staff/Clerk II

**WHEREAS**, there is a need for the amendment of Section 12 of City Ordinance No. 04-2014, in conformity with Civil Service and DBM guidelines with the positions aforementioned above.

**NOW, THEREFORE**, be it **ORDAINED** by the Sixth City Council in session assembled to enact:

**SECTION 1. TITLE.** This Ordinance shall be known as the “*Ordinance Amending Section 12 of the City Ordinance No. 004-2014 – “Tuguegarao City Investments and Incentives Code of 2014.”*”

**SECTION 2. SECTION 12 OF THE INVESTMENTS AND INCENTIVES CODE SHALL BE READ AS FOLLOWS:**

SECTION 12. CITY ECONOMIC AND INVESTMENTS PROMOTION OFFICE.

- a. The City Economic and Investments Promotion Office is hereby created.
- b. To optimize the center, the following positions are hereby outlined and created.

One (1) Development Management Officer IV (City Investments and Promotion Officer)  
 One (1) Development Management Officer II (Investments Development Specialist)  
 One (1) Economic Researcher  
 One (1) Administrative Staff/Clerk II

- c. The Center shall be attached as a regular unit of the Office of the City Mayor.

**SECTION 3. FUNDING FOR THE NEW POSITIONS.** The corresponding funds for the salary and other emoluments and benefits for the above stated positions shall be provided in the Annual Budget and Supplemental Budget of Tuguegarao City.

**SECTION 4.** The filling up of these new positions shall be subject to the Personal Services Limitation (PS Limitation) provision of Section 325 (a) RA 7160 or the Local Government Code of 1991 and pertinent Civil Service Rules and Regulations.

**SECTION 5. SEPARABILITY CLAUSE.** If any part of this Ordinance is declared invalid or unlawful by law or issuances, the other parts not affected thereby shall remain in full force and effect.

**SECTION 6. EFFECTIVITY.** This Ordinance shall take effect upon its approval.


On motion of Hon. Rosauro G. Resuello, duly seconded by Hon. Perla C. Tumaliuan and without any objection from the Body, **CITY ORDINANCE NO. 15-2015** was **UNANIMOUSLY APPROVED** on its Second, Third and Final Reading under suspended rules.
