**CITY RESOLUTION NO. 013-2015**

**A RESOLUTION AUTHORIZING THE CITY VICE MAYOR, HON. BIENVENIDO C. DE GUZMAN II, TO SIGN FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT THE CONTRACT OF SERVICE WITH RBC CABLE MASTER SYSTEM AND CLEARVIEW TELEVISION SYSTEMS, INC. FOR THE COVERAGE OF THE PROCEEDINGS OF THE SANGGUNIANG PANLUNGSOD**

**WHEREAS**, Section 456, paragraph (5) of the Local Government Code of 1991 provides that the City Vice Mayor can exercise such other powers and perform other duties and functions as may be prescribed by law and ordinance;

**WHEREAS**, the Sixth City Council has passed City Ordinance No. 03-2013, otherwise known as An Ordinance Granting Authority to the City Vice Mayor to Enter into a Contract, Memorandum of Agreement or Memorandum of Understanding with Partner Agencies/Establishments/Entities for and in Behalf of the Sangguniang Panlungsod;

**WHEREAS**, the television coverage is a part of public information of all the proceedings of the Sixth City Council for purposes of transparency and accountability;

**WHEREAS**, the Sixth City Council, through the Committee on Laws, Ordinances, Revisions and Legal Matters, studied the provisions stipulated in Contract of Service and made some amendments;


**WHEREAS**, the Committees found the terms and conditions beneficial to both parties.

**NOW THEREFORE, RESOLVED**, as it is hereby **RESOLVED**, to authorize the City Vice Mayor, **HON. BIENVENIDO C. DE GUZMAN II**, to sign for and in behalf of the Tuguegarao City Government the Contract with RBC Cable Master and Clearview Television Systems, Inc. for the television coverage of the Sangguniang Panlungsod sessions.
