CITY RESOLUTION NO. 015-2015

A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ATTY. ENGELBERT C. CARONAN, JR., TO SIGN FOR AND IN BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH EGL BIRTHING CLINIC

WHEREAS, Section 455, paragraph (vi) of the Local Government Code of 1991 provides that "the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance";

WHEREAS, Tuguegarao City Government operates and maintains the Tuguegarao City People's General Hospital located at Tuguegarao City, Cagayan;

WHEREAS, the Tuguegarao City People's General Hospital is a secondary/tertiary hospital with highly trained and competent medical practitioners and equipped with medical set-up and equipment as required of a Maternal-Child friendly hospital;

WHEREAS, EGL Birthing Clinic which handles non-complicated pregnancies with home delivery set-up and does not handle, treat and manage complicated OB-GYNE procedures as well as pediatric cases has manifested its intent to enter into a Memorandum of Agreement with LGU Tuguegarao City;

WHEREAS, the Sixth City Council, through the Committee on Laws, Ordinances, Revisions and Legal Matters and the Committee on Health, studied the provisions stipulated in the Memorandum of Agreement and made some amendments;

WHEREAS, neither the FIRST PARTY (LGU) and the SECOND PARTY (EGL) shall compel any pregnant women of Tuguegarao City to avail of the services of the SECOND PARTY (EGL Birthing Clinic);


WHEREAS, the Committees found the terms and conditions beneficial to both parties and the constituents of Tuguegarao City.
