**WHEREAS**, Section 458 of Republic Act No. 7160 provides that the Sangguniang Panlungsod, as the legislative body of the City, shall enact ordinances and approve resolutions, and appropriate funds for the general welfare of the city and its inhabitants;

**WHEREAS**, the Tuguegarao City Fire Station plays a vital role in the maintenance of public safety, prevention of fire and protection of lives and properties of the constituents of Tuguegarao City;

**WHEREAS**, in carrying out these roles, the Tuguegarao City Firefighters are putting their lives in front of the line, the kind of service that can never be compensated by any amount;

**WHEREAS**, the Bureau of Fire Protection, Office of the City Fire Marshal, has requested for a monthly rice allowance through a request letter dated November 24, 2014 addressed to the City Vice Mayor, Hon. Bienvenido C. De Guzman II;

**WHEREAS**, in consideration of the request and in order to acknowledge their services as firefighters of the City, the Sangguniang Panlungsod of Tuguegarao requests the City Mayor, Hon. Atty. Engelbert C. Caronan, Jr., to appropriate funds for the monthly purchase of three (3) cavans of rice for the Tuguegarao City Fire Station, Office of the City Fire Marshal;

**WHEREAS**, the grant of the request will boost the morale of the city firefighting force and will consequently result to a more efficient and effective service.

**NOW THEREFORE, RESOLVED**, as it is hereby **RESOLVED**, to approve the request of the Tuguegarao City Fire Station for the monthly purchase of three (3) cavans of rice and to request the City Mayor, Hon. Atty. Engelbert C. Caronan, Jr., to appropriate funds thereof.

**RESOLVED FURTHER**, that a copy of this Resolution be furnished to the Office of the City Fire Marshal for information.


