**WHEREAS**, Section 11 of Republic Act No. 9994, otherwise known as the Expanded Senior Citizens Act of 2010 and its Implementing Rules and Regulations (IRR), under Rule VIII, Article 25, mandates the establishment of a Monitoring and Coordinating Mechanism with the specific function of monitoring and reporting efficient, consistent and uniform implementation of the law;

**WHEREAS**, Section 458 (5) (xvii) of the Local Government Code (RA 7160) provides that the Sangguniang Panlungsod shall "establish a city council for the elderly which shall formulate policies and adopt measures mutually beneficial to the elderly and to the community.

**NOW THEREFORE**, be it **RESOLVED**, as it is hereby **RESOLVED**, to approve the establishment of the City Coordinating and Monitoring Board (CCMB) of Tuguegarao City pursuant to

RA 9994 and its Implementing Rules and Regulations (IRR) which shall be composed of:


