WHEREAS, the Philippine Gaming and Amusement Corporation (PAGCOR) is a Government Owned and Controlled Corporation (GOCC) which extends financial assistance to different institutions for programs and projects beneficial to the community;

WHEREAS, in line with the objective of PAGCOR in giving funding assistance, it allocated funds for the construction of buildings in chosen schools, one of which is the Cagayan National High School of Tuguegarao City, Cagayan;

WHEREAS, with the implementation of the K-12 Program, there is an urgent need to construct additional classrooms for the Cagayan National High School of Tuguegarao City, Cagayan;

WHEREAS, Dr. Linda P. Tungcul, Principal of Cagayan National High School, through a letter to Hon. Estelita U. Dayag dated February 20, 2015, requested for the passage of a resolution for the immediate release of the funds from PAGCOR for the construction of the two-storey building, 10 classroom DEPED/PAGCOR School Building adopted from PAGCOR Standard Design.


