CITY RESOLUTION NO. 044-2015

A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ATTY. ENGELBERT C. CARONAN, JR., TO SIGN AND EXECUTE THE MEMORANDUM OF AGREEMENT WITH THE FIL-CANADIAN TRAINING AND DEVELOPMENT CENTER FOR CAREGIVERS INCORPORATED REGARDING THE RENEWAL OF AFFILIATION AND TRAINING OF STUDENTS AT TUGUEGARAO CITY PEOPLE'S GENERAL HOSPITAL IN ACCORDANCE WITH SECTION 2 OF ADMINISTRATIVE ORDER NO. 5-A, SERIES OF 1996 OF THE DEPARTMENT OF HEALTH

WHEREAS, the Memorandum of Agreement entered into by and between the Tuguegarao City Government and Fil-Canadian Training Development Center for Caregivers Incorporated is duly prescribed by the Department of Health under existing laws;

WHEREAS, the Memorandum of Agreement regarding the affiliation and training of students of Fil-Canadian Training Development Center for Caregivers Incorporated is subject to Policies, Procedures and Guidelines governing affiliation and training of students in the Department of Health Hospitals/Rural and City Health Units and other Health Agencies;

WHEREAS, the Tuguegarao City People's General Hospital shall not be responsible for injuries that maybe sustained by students during the course of their training or for acts of negligence of students and acts or events beyond the control of the hospital;

WHEREAS, the Fil-Canadian Training Development Center for Caregivers Incorporated shall be responsible for contingencies caused by or arising from the negligence of its students undergoing affiliation course;

WHEREAS, Fil-Canadian Training Development Center for Caregivers Incorporated shall strictly comply with the Provisions of Administrative Order No.5-A and any violation thereof shall be a legitimate ground for the revocation of the Memorandum of Agreement;

WHEREAS, the renewal of the affiliation shall be reviewed and be approved by the Sangguniang Panlungsod in order to ensure the welfare of the patients of the People's General Hospital and in order to delineate the responsibility of the school with regard to the deployment of students;

WHEREAS, the Tuguegarao City Government reserves the right to revoke, cancel or amend the terms and conditions of the Memorandum of Agreement when it deems necessary but not limited to violations of the terms and conditions or laws, rules and regulations regarding the conduct of affiliation;

NOW, THEREFORE, be it **RESOLVED**, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement entered into by and between the Tuguegarao City People's General Hospital and Fil-Canadian Training Development Center for Caregivers Incorporated, subject to the payment of fees as required by ordinances and resolutions of the City;

RESOLVED FINALLY, to grant authority to the City Mayor, Hon. Atty. Engelbert C. Caronan, Jr., to enter into a Memorandum of Agreement with Fil-Canadian Training Development Center for Caregivers Incorporated for the renewal of affiliation and training of the students at the Tuguegarao City People's General Hospital.
