**A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT AND AUTHORIZING THE CITY MAYOR, HON. ATTY. ENGELBERT C. CARONAN, JR., TO SIGN FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT REGIONAL FIELD OFFICE NO. 02 REGARDING THE IMPLEMENTATION OF THE SOCIAL PENSION FOR INDIGENT SENIOR CITIZENS IN THE AMOUNT OF P500.00 AS GOVERNMENT ASSISTANCE STIPULATED UNDER REPUBLIC ACT 9994**

**WHEREAS**, the Department of Social Welfare and Development (DSWD) is mandated to provide social welfare and development programs particularly through technical assistance and resource augmentation;

**WHEREAS**, the DSWD is continuously implementing programs/projects and providing augmentation assistance to the local government units (LGUs), non-government organizations and other partner agencies that would help alleviate poverty and ensure welfare of the disadvantaged and vulnerable groups;

**WHEREAS**, the Social Pension for Indigent Senior Citizens is an additional government assistance to augment the daily subsistence and other medical needs of indigent senior citizens;

**WHEREAS**, fund transfer to LGU is identified as a mode of payment to fast tract the distribution of stipend to the beneficiaries and to strengthen partnership with LGUs in the effective delivery of programs and services.

**NOW THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to authorize the City Mayor, Hon. Atty. Engelbert C. Caronan, Jr., to sign for and in behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Social Welfare and Development Regional Office



No. 02, represented by its Regional Executive Director Remia T. Tapispisan for the Social Pension for Indigent Senior Citizens in the amount of P500.00 as government assistance stipulated under RA 9994.
