Caronan, Jr., to sign for and in behalf of the Tuguegarao City Government the Specific Implementation Agreement with the Department of Social Welfare and Development Regional Office No. 02 represented by its Regional Executive Director Remia T. Tapispisan and the Provincial Government of Cagayan for the Pantawid Pamilyang Pilipino Program.
