CITY RESOLUTION NO. 049-2015

A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ATTY. ENGELBERT C. CARONAN, JR., TO SIGN FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT THE SPECIFIC IMPLEMENTATION AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT REGIONAL OFFICE NO. 02 AND THE PROVINCIAL GOVERNMENT OF CAGAYAN FOR THE PANTAWID PAMILYANG PILIPINO PROGRAM

WHEREAS, the Department of Social Welfare and Development (DSWD) is continuously implementing programs/projects and providing augmentation assistance to the local government units (LGUs), non-government organizations and other partner agencies that would help alleviate poverty and ensure welfare of the disadvantaged and vulnerable groups;

WHEREAS, the DSWD is mandated to provide social welfare and development programs particularly through technical assistance and resource augmentation;

WHEREAS, the implementation of Pantawid Pamilyang Pilipino Program for extremely poor households aims to build human capital through accessing health, nutrition and education services;

WHEREAS, Tuguegarao City Government expressed its interest and willingness to be the partner of the DSWD and other agencies in the implementation of Pantawid Pamilyang Pilipino Program to improve the condition of its poor constituents.

NOW THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to authorize the City Mayor, Hon. Atty. Engelbert C. Caronan, Jr., to sign for and in behalf of the Tuguegarao City Government the Specific Implementation Agreement with the Department of Social Welfare and Development Regional Office No. 02 represented by its Regional Executive Director Remia T. Tapisipan and the Provincial Government of Cagayan for the Pantawid Pamilyang Pilipino Program.
