A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT AND AUTHORIZING THE CITY MAYOR, HON. ATTY. ENGELBERT C. CARONAN, JR., TO SIGN FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE REGIONAL OFFICE NO. 02 FOR THE PROCUREMENT OF FARM MACHINERIES/EQUIPMENT (CORN GRIT MILL) UNDER THE AGRI-PINOY CORN PROGRAM

WHEREAS, the Department of Agriculture Regional Field Office No. 02 (DA-RFO 02) has launched the Agri-Pinoy Corn Program to boost agricultural productivity;

WHEREAS, one of the key interventions of DA-RFO 02 under the Corn Program is the provision of post harvest facilities to support the promotion of white corn as food;

WHEREAS, the Corn Grit Mill, will be given by the DA-RFO 02 as grant to the city government but will have to be sheltered again and to include the construction of the gate at the demo farm for safety measures and it will be charged in the realigned fund;

WHEREAS, the Tuguegarao City Government has signified its interest to avail of the project to be implemented in Tuguegarao City, authorized the City Mayor to enter into a Memorandum of Agreement with DA-RFO 02 for the said subject.

NOW THEREFORE, RESOLVE, as it is hereby RESOLVED, to authorize the City Mayor, Hon. Atty. Engelbert C. Caronan, Jr., to sign for and in behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Agriculture Regional Field Office No. 02 represented by its Regional Executive Director Lucrecio R. Alviar, Jr., for the procurement of farm machineries/equipment (Corn Grit Mill) under the Agri-Pinoy Corn Program.
