CITY RESOLUTION NO. 053-2015

A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ATTY. ENGELBERT C. CARONAN, JR., TO SIGN AND EXECUTE THE MEMORANDUM OF AGREEMENT WITH MAILA ROSARIO COLLEGE REGARDING THE EIGHTY (80) HOURS PLACEMENT PROGRAM FOR CAREGIVING TRAINEES AT THE TUGUEGARAO CITY PEOPLE'S GENERAL HOSPITAL

WHEREAS, Section 455, paragraph I (vi) of the Local Government Code of 1991 provides that the Local Chief Executive represents the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, Tuguegarao City Ordinance No. 06-2008 prescribes the guidelines in the affiliation of schools, colleges and universities for the affiliation and training of students and the use of health and medical facilities of Tuguegarao City for the On-the-Job Training (OJT) of students taking up medical courses and other allied health services;

WHEREAS, the Memorandum of Agreement entered into by and between the Tuguegarao City Government and Maila Rosario College is duly prescribed by the Department of Health under existing laws;

WHEREAS, the Memorandum of Agreement regarding the affiliation and training of students of Maila Rosario College are subject to Policies, Procedures and Guidelines governing affiliation and training of students in the Department of Health Hospitals/Rural and City Health Units and other health agencies;

WHEREAS, the Tuguegarao City People's General Hospital shall not be responsible for injuries that maybe sustained by the students during the course of their training or for acts of negligence of the students and acts or events beyond the control of the hospital;



WHEREAS, Maila Rosario College shall be responsible for contingencies caused by or arising from the negligence of its students undergoing affiliation course;

WHEREAS, Maila Rosario College shall strictly comply with the provisions of Administrative Order No. 5-A and any violation thereof shall be a legitimate ground for the revocation of the Memorandum of Agreement;

WHEREAS, the renewal of affiliation shall be reviewed and be approved by the Sangguniang Panlungsod in order the welfare of the patients of the Tuguegarao City People's General Hospital and in order to delineate the responsibility of the school with regards to the deployment of students;

WHEREAS, the Tuguegarao City Government reserves the right to revoke, cancel or amend the terms and conditions of the Memorandum of Agreement when it deems necessary but not limited to violations of the terms and conditions or laws, rules and regulations regarding the conduct of affiliation.

NOW THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement entered into by and between the Tuguegarao City People's General Hospital and Maila Rosario College, subject to the payment of fees as required by ordinance or resolutions of the city.

RESOLVED FURTHER, to grant authority to the City Mayor, Hon. Atty. Engelbert C. Caronan, Jr., to enter into a Memorandum of Agreement with Maila Rosario College regarding the eighty (80) hours Placement Program for caregiving trainees at the Tuguegarao City People's Hospital.

On motion of Hon. Aurora A. Ave, duly seconded by Hon. Perla C. Tumaliuan, and with the inhibition of Hon. Maila Rosario T. Que, **CITY RESOLUTION NO. 053-2015** was **UNANIMOUSLY APPROVED**.
