RESOLUTION REQUESTING THE DEPARTMENT OF TRADE AND INDUSTRY, REGIONAL OFFICE NO. 2 TO CLOSELY MONITOR THE COMPLIANCE OF THE DRUGSTORES IN TUGUEGARAO CITY TO REPUBLIC ACT 9994 OTHERWISE KNOWN AS AN ACT GRANTING ADDITIONAL BENEFITS TO SENIOR CITIZENS

WHEREAS, Republic Act No. 9994, also known as "An Act Granting Additional Benefits and Privileges to Senior Citizens" further amending Republic Act No. 7432, otherwise known as "An Act to Maximize the Contribution of Senior Citizens to Nation building, Grant Benefits and Special Privileges and Other Purposes" provides that senior citizens are granted 20% discount on the sale of medicines and services in all establishments;

WHEREAS, there are drugstores in Tuguegarao City that conceal the availability of medicines to them as complained by senior citizens;

WHEREAS, to address the said issue, the Sixth City Council highly recommends the close monitoring by the Department of Trade and Industry Region 02 of the implementation of RA 9994 to safeguard the welfare of the senior citizens in the City.

NOW THEREFORE RESOLVE, as it is hereby RESOLVED, to request the Department of Trade and Industry, RO2 to closely monitor the compliance of the drugstores in the City in the implementation of Republic Act 9994 - "An Act Granting Additional Benefits and Privileges to Senior Citizens."
