**A RESOLUTION AUTHORIZING HON. BIENVENIDO C. DE GUZMAN II TO SIGN CHECKS, PAYROLLS, VOUCHERS, DAILY TIME RECORDS, TRAVEL ORDERS, PURCHASE REQUESTS AND OTHER MINISTERIAL DOCUMENTS RELATIVE TO THE OPERATIONS OF THE SANGGUNIANG PANLUNGSOD AND THE OFFICE OF THE CITY VICE MAYOR**

**WHEREAS**, the Honorable Court of Appeals Special Eighth Division has rendered decision in case CA-G.R. SP no. 137209, Jefferson P. Soriano vs. the Honorable Conchita Carpio-Morales, etc., et. al., promulgated on April 16, 2015;

**WHEREAS**, the dispositive clause of the Honorable Court of Appeals Special Eighth Division's Decision reads as follows: "*Considering that the period of Petitioner Soriano's removal from office has exceeded three months, we order petitioner Soriano IMMEDIATELY REINSTATED*";

**WHEREAS**, by virtue of the Decision of the Honorable Court of Appeals Special Eighth Division, Hon. Jefferson P. Soriano assumed office as City Mayor of Tuguegarao City, Cagayan on April 20, 2015 and has informed the Hon. Engelbert C. Caronan, Jr., City Vice Mayor, through a letter that he has assumed office as City Mayor and is performing the duties and functions as City Mayor in faithful compliance to the Honorable Court of Appeals Special Eighth Division's Decision;

**WHEREAS**, in the absence of the City Vice Mayor, Hon. Engelbert C. Caronan, Jr., who has not reported to office since the reinstatement of the City Mayor Hon. Jefferson O. Soriano, the Hon.

Bienvenido C. De Guzman II, the highest ranking Member of the Sangguniang Panlungsod of Tuguegarao City, is Acting City Vice Mayor, so as not to create a vacuum in the Legislative Branch which will prejudice public welfare;

**WHEREAS**, in order not to paralyze the operations of the Sangguniang Panlungsod and the Office of the City Vice Mayor, the Sixth City Council hereby authorizes Hon. Bienvenido C. De Guzman II to sign checks, payrolls, vouchers, daily time records, travel orders, purchase requests and other ministerial documents relative to the operations of the Sangguniang Panlungsod and the Office of the City Vice Mayor.

**NOW THEREFORE, RESOLVED**, as it is hereby **RESOLVED**, to authorize Hon. Bienvenido C. De Guzman II to sign checks, payrolls, vouchers, daily time records, travel orders, purchase requests and other ministerial documents relative to the operations of the Sangguniang Panlungsod and the Office of the City Vice Mayor.


On motion of Hon. Noel A. Mora, duly seconded by Hon. Perla C. Tumaliuan, and without any objection from the Body, **CITY RESOLUTION NO. 071-2015** was **UNANIMOUSLY APPROVED**.
