### A RESOLUTION AMENDING CITY RESOLUTION NO. 061-2015 AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH REGIONAL OFFICE NO. 2 AND THE PEOPLE'S GENERAL HOSPITAL FOR THE IMPLEMENTATION OF THE MEDICAL ASSISTANCE PROGRAM (MAP)

WHEREAS, the amount of P3,193,000.00 was allocated for medical assistance to indigent and poor patients;

WHEREAS, Administrative Order (AO) No. 201-0024 dated July 15, 2014 on Medical Assistance to Indigent and Poor Patients in Government Hospitals issued by the Secretary of Health repealed Administrative Order No. 2014-0013 dated April 7, 2014 and Administrative Order No. 2014-0017 for the transfer of funds to recipient government hospitals of the Medical Assistance Program of the Department of Health;

WHEREAS, the amount of Two Hundred Thousand (P200,000.00) was allocated to Tuguegarao City People's General Hospital for the implementation of the program under continuing program;

WHEREAS, Tuguegarao City People's General Hospital is willing to participate in the efficient and effective grant of medical assistance to indigent and poor patients;

WHEREAS, Tuguegarao City Government is willing to assist the DOH on the implementation of the project;

WHEREAS, the Tuguegarao City Government has the capacity and ability to implement the said project as signified in their letter-request to undertake the same;
