CITY RESOLUTION NO. 079-2015

RESOLUTION OF NO OBJECTION (RONO) APPROVING THE REQUEST OF MR. TERRY GONZAGA, PRESIDENT, FAUSTUS PRIMITUS GAMING CORPORATION, FOR THE TRANSFER OF E-GAMES FROM ALVIN BUILDING, BALZAIN HIGHWAY, TUGUEGARAO CITY, CAGAYAN TO ATI BUILDING, DON DOMINGO, TUGUEGARAO CITY, CAGAYAN

WHEREAS, a Provisional Certificate to Operate PAGCOR E-Games Station was issued by Philippine Amusement and Gaming Corporation (PAGCOR) to FAUSTUS PRIMITUS GAMING CORPORATION located at ATI Building, Don Domingo, Tuguegarao City, Cagayan;

WHEREAS, Mr. Terry Gonzaga, President, Faustus Primitus Gaming Corporation (E-Games), requested for a Resolution of No Objection (RONO) from the Sanggunian for the transfer of PAGCOR E-Games site from Alvin Building, Balzain Highway, Tuguegarao City, Cagayan to ATI Building, Don Domingo, Tuguegarao City, Cagayan;

WHEREAS, Mr. Terry Gonzaga has submitted the following documents:


