**WHEREAS**, the LGU-Tuguegarao is mandated to extend assistance to agencies and entities in the discharge of their functions and duties to facilitate easy access to the basic needs and services of its constituents;

**WHEREAS**, Tuguegarao City Government has a vacant office space located at the former office of the City Fire Marshal located along Magallanes Street, Tuguegarao City, Cagayan which may temporarily be used for free by the Philippine Veterans Affairs Office (PVAO) as its office;


**NOW THEREFORE**, for and in consideration of the above-premises.


