WHEREAS, the repair of the eleven (11) classrooms of North Central Elementary School of Tuguegarao City is vital to ensure that its pupils are safe and have no apprehension of displacement;

WHEREAS, the Special Education Fund (SEF) intended to subsidize and support the public schools of Tuguegarao City is not sufficient due to the voluminous pupil/student population and the numerous classrooms in different campuses;



WHEREAS, to augment the allocation from the Special Education Fund (SEF), it is necessary to source alternative means of funding.


