CITY RESOLUTION NO. 098-2015

A RESOLUTION AUTHORIZING THE SUBSIDIZED OPERATION OF CORN PICKER FOR TUGUEGARAO CITY CORN FARMERS EFFECTIVE 2015 AND TO COLLECT A SERVICE FEE OF P1,000.00 PER HECTARE AS AGREED UPON BY THE CITY AGRICULTURAL AND FISHERY COUNCIL (CAFC)

WHEREAS, Section 5 of Article XIII of the Philippine Constitution provides that *“the State shall recognize the right of farmers, farm workers and landowners as well as cooperatives and other independent farmers’ organizations to participate in the planning, organization, and management of the program, and shall provide support to agriculture through appropriate technology and research, and adequate financial, production, marketing and other support services.”*;

WHEREAS, the City Agricultural and Fishery Council (CAFC) passed Resolution No. 03-2015, *“CAFC Resolution Requesting the Operation of Corn Picker for Tuguegarao City Corn Farmers Effective 2015”*;

WHEREAS, the said Resolution was endorsed by the City Mayor, Hon. Jefferson P. Soriano, to the Sixth City Council for perusal and appropriate action;

WHEREAS, the operation of the said Mechanized Corn Picker is in line with the Agricultural and Fisheries Modernization Program of Tuguegarao City;

WHEREAS, the use of the Mechanized Corn Picker shall promote efficiency and productivity relating to harvest and post-harvest activities;

WHEREAS, per computation of the City Agriculturist Office, to operate the Mechanized Corn Picker on a per hectare basis, about 30 to 32 liters of diesel is needed or an equivalent of P1,188.00 at prevailing price;

WHEREAS, harvesting of corn utilizing manual labor will cost P200.00 per laborer and P2,000.00 for 10 laborers needed per hectare;

WHEREAS, CAFC agreed that an amount of P1,000.00 per hectare shall be collected from the corn farmers for the use of the Mechanized Corn Picker;

WHEREAS, there is a difference of P188.00 per hectare for the use of the said equipment being collected by private business and the amount of P1,000.00 per hectare as recommended by CAFC to be collected from the corn farmers and payable directly to the City Treasurer's Office;

WHEREAS, the above-stated amount of P188.00 shall be considered as the subsidy of the City Government per hectare to the Tuguegarao City corn farmers availing of the services of the mechanized corn picker.

NOW THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to authorize the subsidized operation of Corn Picker for Tuguegarao City corn farmers effective 2015 and to collect a service fee of P1,000.00 per hectare as agreed upon by the CAFC.


RESOLVED FURTHER, to forward a copy of this Resolution to the Local Chief Executive, the Hon. Atty. Jefferson P. Soriano, for implementation.

RESOLVED FINALLY, to forward a copy of this Resolution to the City Agricultural and Fisheries Council (CAFC), the City Treasurer and the City Agriculturist for information and implementation.


On motion of Hon. Estelita U. Dayag and without any objection from the Body, **CITY RESOLUTION NO. 098-2015** was **UNANIMOUSLY APPROVED** on its Third and Final Reading under suspended rules.
