CITY RESOLUTION NO. 099-2015

A RESOLUTION AUTHORIZING THE SUBSIDIZED OPERATION OF ONE (1) UNIT VILLAGE-TYPE CORN PROCESSOR FOR TUGUEGARAO CITY CORN FARMERS AT THE GOSI DEMO FARM AND THE CHARGING OF A SERVICE FEE OF FIFTY CENTAVOS (P0.50) PER KILO OF CORN PROCESSED AS AGREED UPON BY THE CITY AGRICULTURAL AND FISHERY COUNCIL (CAFC)

WHEREAS, Section 5 of Article XIII of the Philippine Constitution provides that *“the State shall recognize the right of farmers, farm workers and landowners as well as cooperatives and other independent farmers’ organizations to participate in the planning, organization, and management of the program, and shall provide support to agriculture through appropriate technology and research, and adequate financial, production, marketing and other support services.”*;

WHEREAS, the City Agricultural and Fishery Council (CAFC) passed Resolution No. 04-2015, "CAFC Resolution Requesting the Operation of One (1) Unit Village-Type Corn Processing Center for Tuguegarao City Corn Farmers Effective 2015";

WHEREAS, the said CAFC Resolution was endorsed by the City Mayor, Hon. Jefferson P. Soriano, to the Sixth City Council for perusal and appropriate action;

WHEREAS, the operation of the said unit at the Demo Farm, Gosi Norte is in line with the Agricultural and Fisheries Modernization Program of Tuguegarao City;

WHEREAS, the use of the said unit for post-harvest activities covered by the wet cropping season shall minimize production losses which would mean additional income to corn farmers;

WHEREAS, per computation of the City Agriculturist Office, the prevailing service fee being charged in the processing of per kilo of corn by private business amounts to 99 centavos;

WHEREAS, CAFC Resolution No. 04-2015 has recommended the amount of 50 centavos service fee per kilo of corn processed to be collected from the corn farmers payable directly to the City Treasurer's Office;

WHEREAS, there is a difference of 44 centavos between prevailing service fee of 99 centavos per kilo of corn processed being collected by private business and the amount 50 centavos of what is being agreed upon and recommended by the CAFC under the aforecited resolution;

WHEREAS, the above-stated amount of 44 centavos shall be considered as the subsidy of the City Government to the corn farmers availing of the service of the one (1) unit village-type corn processor for 2015.

NOW THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to authorize the subsidized operation of one (1) unit Village-Type Corn Processor for Tuguegarao City Corn Farmers at the Gosi Demo Farm and to charge a service fee of 50 centavos per kilo of corn processed as agreed upon by the CAFC.


RESOLVED FURTHER, to forward a copy of this Resolution to the Local Chief Executive, the Hon. Atty. Jefferson P. Soriano, for implementation.

RESOLVED FINALLY, to forward a copy of this Resolution to the City Agricultural and Fisheries Council (CAFC), the City Treasurer and the City Agriculturist for information and implementation.


On motion of Hon. Estelita U. Dayag and without any objection from the Body, **CITY RESOLUTION NO. 099-2015** was **UNANIMOUSLY APPROVED** on its Third and Final Reading under suspended rules.
