**A RESOLUTION APPROVING THE HOLDING OF THE FIESTA CARNIVAL AND
AUTHORIZING THE CITY MAYOR TO TRANSACT WITH QUALIFIED OPERATORS**

WHEREAS, by virtue of Committee Report No. 047-2015 as amended and adopted on the Regular Session of the Sangguniang Panlungsod on July 07, 2015, the conduct of Fiesta Carnival from July 27 to September 15, 2015 was approved;

NOW THEREFORE, RESOLVED, to approve the holding of the Fiesta Carnival from July 27 to September 15, 2015 and to grant authority to Tuguegarao City Mayor, Hon. Jefferson P. Soriano, to transact with interested and qualified operators on the following conditions:


For the Operator:

1. To secure a Mayor's Permit;
2. To maintain the cleanliness and sanitation within the premises;
3. To secure and ensure the safety of the vicinity;
4. Not to extend the time and days of operation;
5. To pay the 10% Amusement Tax; and,
6. To pay other fees and charges as mandated by law.


On motion of Hon. Rosauro G. Resuello, with the inhibition of Hon. Aurora A. Ave and without any objection from the Body, **CITY RESOLUTION NO. 105-2015** was **APPROVED** as amended on its Second and Final Reading under suspended rules.
