## CITY RESOLUTION NO. 106-2015

### A RESOLUTION AUTHORIZING THE TEMPORARY CLOSURE OF PORTION OF GONZAGA STREET, FROM THE CORNER BURGOS TO TAFT STREETS, PORTION OF DEL ROSARIO STREET, FROM CORNER GONZAGA TO GOMEZ STREETS, AND PORTION OF GOMEZ STREET, FROM BURGOS TO TAFT STREETS FOR THE "BARATILLO" FLEA MARKET FROM JULY 27, 2015 TO SEPTEMBER 15, 2015

WHEREAS, pursuant to the pertinent provisions of Section 21 of Republic Act 7160, otherwise known as the Local Government Code, the Local Government Unit of Tuguegarao is authorized to close some of the local roads falling within its jurisdiction;

WHEREAS, the Patronal Feast of Tuguegarao City known as Pavvurulun "AFI" Festival is observed annually with the conduct of various socio-economic and cultural activities;

WHEREAS, among the activities to be undertaken in the said celebration is the holding of the traditional "Batatillo" or Flea Market;

WHEREAS, a comprehensive and integrated plan on transfer and relocation, traffic management, safety and security, and health and sanitation including the site plan and layout for the conduct of the "Baratillo" 2015 was submitted.

**NOW THEREFORE, RESOLVED,** as it is hereby **RESOLVED**, to authorize the City Mayor, Hon. Atty. Jefferson P. Soriano, to temporarily close portion of Gonzaga Street, from corner Burgos to Taft Streets, portion of Del Rosario Street, from corner Gonzaga to Gomez Street, from Burgos to Taft Streets for the "Baratillo" Flea Market activity from July 27, 2015 to September 15, 2015.
