**CITY RESOLUTION NO. 109-2015**

**A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, FOR THE TEMPORARY PARTIAL CLOSURE OF THE ENRILE BOULEVARD STREET, CARIG SUR, TUGUEGARAO CITY ON AUGUST 04 AND 06, 2015 FROM 8:00 AM-12:00 NN AND ON AUGUST 07, 2015 FROM 8:00 AM TO 12:00 NN AND 3:00 PM TO 9:00 PM FOR THE PAVVURULUN "AFI" FESTIVAL PRESENTATION AND TEMPORARY ROAD CLOSURE OF BONIFACIO STREET ON AUGUST 4-7, 2015 FROM 6:00 AM TO 9:00 AM AND 12:00 NN TO 3:00 PM AND ON AUGUST 8, 2015 FROM 5:00 AM TO 2:00 PM FOR THE TUGSAYAW**

**WHEREAS**, pursuant to Section 21 of Republic Act 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit of Tuguegarao is authorized to declare any closure of local roads falling within its jurisdiction;

**WHEREAS**, pursuant to Rule VIII, Article 45 of the Implementing Rules and Regulations of the Local Government Code of 1991, "Any national or local road, alley, park, or square may be temporarily closed during fiesta celebrations for a period not exceeding nine (9) days;

**WHEREAS**, Tuguegarao City shall be celebrating its 291<sup>st</sup> Patronal Feast dubbed as Pavvurulun "AFI" Festival on August 5-16, 2015;

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, requested an authority from the Council for the temporary partial closure of the Enrile Boulevard Street, Carig Sur, Tuguegarao City on August 04 and 06, 2015 from 8:00 AM to 12:00 NN and on August 07, 2015 from 8:00 AM to 12:00 NN and 3:00 PM to 9:00 PM for the Pavvurulun "AFI" Festival presentation and temporary road closure of Bonifacio Street on August 4-7, 2015 from 6:00 AM to 9:00 AM and 12:00 NN to 3:00 PM and on August 8, 2015 from 5:00 AM to 2:00 PM for the Tugsayaw.

**NOW THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to authorize the City Mayor, Hon. Atty. Jefferson P. 
