RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, ATTY. JEFFERSON P. SORIANO, TO SIGN AND EXECUTE FOR AND IN BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE, REGIONAL FIELD OFFICE NO. 2 FOR THE IMPLEMENTATION OF THE CY 2015 BOTTOMS-UP BUDGETING PROJECTS

WHEREAS, in pursuit of the Millennium Development Goal of reducing poverty from 26.5% in 2009 to 16.6% by 2015 and attaining the Philippine Development Plan's goal of inclusive growth and poverty reduction, the Human Development and Poverty Reduction Cluster (HDPRC), the Good Governance and Anti-Corruption Cluster (GGAC) and the Economic Development Cluster (EDC) organized under Executive Order No. 43, series of 2011 shall implement Bottom-up Budgeting (BuB) to ensure the inclusion of the funding requirements for the development needs of focus cities and municipalities in the budget proposals of the participating agencies;

WHEREAS, the Department of Agriculture (DA) is one of the participating agencies in the BuB that aims to provide livelihood opportunities to targeted communities and institutionalize a decentralized system for agriculture and fisheries service delivery that promotes participation, transparency and sustainability;

WHEREAS, the Department of Agriculture (DA), Department of Budget and Management (DBM), the National Economic Development Authority (NEDA) and the Department of the Interior and Local Government (DILG) were provided with funds to support the implementation expenditures in carrying out the various projects in the Bottom-up Budgeting Program;

WHEREAS, LGU Tuguegarao City is a recipient of three projects under the CY 2015 Bottom-up Budgeting Projects of the Department of Agriculture;
