RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT AND AUTHORIZING THE HONORABLE CITY MAYOR, ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FOR THE IMPLEMENTATION OF A UNIFIED MOA FOR THE SUSTAINABLE LIVELIHOOD PROGRAM (SLP) AND SUPPLEMENTAL FEEDING PROGRAM (SFP)

WHEREAS, the Human Development and Poverty Reduction Cluster (HDPRC), the Good Governance and Anti-Corruption Cluster (GGAC) and the Economic Development Cluster (EDC) organized under Executive Order No. 43, series of 2011, issued DBM-DSWD-NAPC Joint Memorandum Circular (JMC) No. 1, series of 2013 to serve as a basis for the implementation of Bottom-up Planning and Budgeting (BuB) for FY 2015 budget preparation;

WHEREAS, the BuB which aims to make the planning budgeting process of both local and national government more participatory by involving grassroots communities in the delivery of national services to poor communities be adopted by different national and local government agencies as part of their poverty reduction effort;

WHEREAS, pursuant to JMC No. 3, series of 2012, dated December 9, 2012, specifying the guidelines for the implementation and monitoring of BuB Projects for FY 2015, both the DSWD and the Local Government Unit and/or CSOs shall uphold the principle of people empowerment even during the course of and post project implementation;

WHEREAS, the Department of Social Welfare and Development (DSWD), through the Protective Services Unit (PSU) Kapit Bisig Laban sa Kahirapan - Comprehensive and Integrated Delivery of Services (KALAHI-CIDSS) and Sustainable Livelihood Program (SLP), National and Regional Project Management Offices (NPMO and RPMOs), assisted the HDPRC in the implementation

of the pilot phase by facilitating the conduct of the BuB Planning Activities specifically in 223 municipalities nationwide;

WHEREAS, LGU Tuguegarao City is eligible to implement the Sustainable Livelihood Program and Supplemental Feeding Program of the Department of Social Welfare and Development.

NOW THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor, Atty. Jefferson P. Soriano, to sign for and in behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Social Welfare and Development Regional Office No. 02, represented by its Regional Executive Director Remia T. Tapispisan, regarding the Unified MOA for the Supplemental Feeding Program and Sustainable Livelihood Program (SLP).

On motion of Hon. Noel A. Mora, duly seconded Hon. Estelita U. Dayag and Hon. Perla C. Tumaliuan and without any objection from the Body, CITY RESOLUTION NO. 112-2015 was UNANIMOUSLY APPROVED under suspended rules.
