WHEREAS, Tuguegarao City Government operates the Tuguegarao City People's General Hospital (TCPGH), which is a first level, 68-bed capacity hospital;

WHEREAS, there is no licensed radiologist/ultrasonologist employed at TCPGH;

WHEREAS, Dr. Vivian C. Valdepeñas is a duly licensed Radiologist/Ultrasonologist, well trained private practitioner with sufficient experience and skill in Radiology/Ultrasonology;


WHEREAS, Dr. Valdepeñas offered her professional services as Radiologist/Ultrasonologist to the TCPGH on contractual basis.

RESOLVE, as it is hereby **RESOLVED**, to approve the Contract of Service between the TCPGH and **DR. VIVIAN VALDEPEÑAS** and grant authority to the Honorable City Mayor, Atty. Jefferson P. Soriano, to sign for and in behalf of the Tuguegarao City Government the Contract of Service with Dr. Vivian Valdepeñas.


