SORIANO, TO SIGN FOR AND IN BEHALF OF TUGUEGARAO CITY THE DEED OF USUFRUCT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE DEPARTMENT OF EDUCATION DIVISION OF TUGUEGARAO CITY FOR THE BENEFICIAL USE OF THE 1,500 SQUARE METER LOT AS THE SITE FOR THE CONSTRUCTION OF THE SCHOOLS DIVISION OFFICE BUILDING

WHEREAS, the request for authority to enter into and sign a Deed of Usufruct for and on behalf of the city government has been endorsed by the City Mayor, Hon. Atty. Jefferson P. Soriano, to the Sixth City Council for reference and evaluation;

WHEREAS, the Tuguegarao City Government, in its effort to improve the delivery of basic quality education, intends to grant the beneficial use of the 1,500 square meter portion of its lot within the premises of the City Hall as the site for the construction of the Schools Division Office Building;



WHEREAS, the joint Committees on Education and Laws reviewed the Deed of Usufruct and incorporated some amendments;

WHEREAS, while the usufruct and/or the beneficial use of the site is transferred to the Usufructuary, the ownership and title of the site remains with and continues to be in the name of the Owner;

WHEREAS, the site shall be exclusively used for the purpose for which it is intended and the Usufruct shall not allow any person/entity to use the site for any purposes without the expressed consent of the owner.

NOW THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to authorize the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and in behalf of Tuguegarao City the Deed of Usufruct between the Tuguegarao City Government and the Department of Education Division of Tuguegarao City for the use of the 1,500 square meter lot as the site for the construction of the Schools Division Office Building.


RESOLVED FURTHER, to forward this Resolution to the Local Chief Executive, the Hon. Atty. Jefferson P. Soriano, for information.
