CITY RESOLUTION NO. 130-2015

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT AND AUTHORIZING THE HONORABLE CITY MAYOR, ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND AMONG THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE), THE PHILIPPINE OVERSEAS EMPLOYMENT ADMINISTRATION (POEA), THE OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) AND THE TECHNICAL EDUCATION SKILLS DEVELOPMENT AUTHORITY (TESDA)

WHEREAS, many Filipinos leave every day for overseas employment in search of job opportunities and consequently alleviating the economic status of their families back home and contributing to the economic stability of the country;

WHEREAS, the low level of or lack of awareness on overseas employment, particularly the programs and services that concerned government agencies and local government units provide to the public, increases the vulnerability of the public migrants and their family members;

WHEREAS, the government has continuously strengthened its information campaign on its national policies and programs and services for the public and migrant workers, specifically on welfare services and illegal recruitment, and anti-trafficking in persons, skills training, reintegration and public information and education;

WHEREAS, Republic Act No. 8042 as amended by RA 10022 mandates local government units, in partnership with the concerned government agencies, to take proactive stance in disseminating information to their constituents on all aspects of overseas employment.


NOW, THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor, Atty. Jefferson P. Soriano, to enter, sign and execute for and in behalf of the Tuguegarao

City Government the Memorandum of Agreement with Department of Labor and Employment (DOLE), Philippine Overseas Employment Administration (POEA), the Overseas Workers Welfare Administration (OWWA), and the Technical Skills Development Authority (TESDA) to strengthen partnership and collaboration in fighting illegal recruitment and human trafficking.
