CITY RESOLUTION NO. 131-2015

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR,
ATTY. JEFFERSON P. SORIANO, TO ENTER, SIGN AND EXECUTE THE
MEMORANDUM OF AGREEMENT WITH THE BUREAU OF FISHERIES AND AQUATIC
RESOURCES (BFAR) FOR THE TRANSFER OF ONE (1) UNIT OF MOBILE TABLET
WITH ONE (1) YEAR SUBSCRIPTION TO ENSURE SPEEDY AND CONSISTENT
SUBMISSION OF REPORT/REGISTRATION TO BFAR'S BOATR DATA BASE

WHEREAS, the 1987 Philippine Constitution directs the state to protect the rights of subsistence fishermen, especially of local communities, to the preferential use of communal marine and fishing resources, both inland and offshore and to provide support thereto through appropriate technology and research, adequate financial production and marketing assistance and other services;

WHEREAS, Bureau of Fisheries and Aquatic Resources (BFAR) is the government agency responsible for the development, protection, management and conservation of the country's fisheries and aquatic resources;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates the LGU to support effective water resource utilization and conservation projects and enforce fishery laws in the city and municipal waters;

WHEREAS, under Republic Act No. 8550, otherwise known as Fisheries Code of 1998, and RA 7160, coastal cities and municipalities have the responsibility to register fishing vessels and fishing gears used by municipal or city fisherfolk;

WHEREAS, BFAR launched BoatR in 2014 to assist cities and municipalities register the city/municipal fishing vessel and gears of subsistent fisherfolks as mandated by the Fisheries Code of 1998;



WHEREAS, to fast track the registration process, BFAR is providing LGU Tuguegarao City one (1) unit of mobile tablet with one (1) subscription to ensure speedy and consistent submission of report to the BFAR's BoatR Data Base.

NOW, THEREFORE, RESOLVED, as it is hereby RESOLVED, to grant authority to the Honorable City Mayor, Atty. Jefferson P. Soriano, to enter, sign and execute for and in behalf of the Tuguegarao City Government the Memorandum of Agreement with the Bureau of Fisheries and Aquatic Resources, represented by its OIC Regional Director, Milagros Morales, for the transfer of one (1) unit of mobile tablet with one (1) year subscription to ensure speedy and consistent submission of report/registration to BFAR's BoatR data base pursuant to RA 8550.

On motion of Hon. Noel A. Mora, duly seconded by Hon. Estelita U. Dayag and without any objection from the Body, CITY RESOLUTION NO. 131-2015 was UNANIMOUSLY APPROVED on its Second and Final Reading under suspended rules.
