CITY RESOLUTION NO. 134-2015

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, ATTY. JEFFERSON P. SORIANO, TO ENTER, SIGN AND EXECUTE FOR AND IN BEHALF OF TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH REGIONAL OFFICE NO. 2 FOR THE IMPLEMENTATION OF THE CY 2014 HEALTH FACILITIES ENHANCEMENT PROGRAM FOR THE UPGRADING OF TUGUEGARAO CITY HEALTH OFFICE AND TEN (10) BARANGAY HEALTH STATIONS (BHS) WHICH WERE INCLUDED IN THE LIST OF FUNDED BOTTOM-UP BUDGETING (BuB) CIVIL WORK PROJECTS

WHEREAS, the 16th Congress appropriated the amount of Php355,110,000.00 under Republic Act 10633 known as the General Appropriations Act of 2014;

WHEREAS, the Department of Health (DOH) through the Office of the Secretary issued Department Order No. 2014-0071 dated April 14, 2014 regarding the Guidelines for the Release and Utilization of Funds to Cover Health Facilities Enhancement Program/Projects to Regional Offices for allocation to different LGU facilities;

WHEREAS, the amount of Three Million Pesos (Php3,000,000.00) is allocated to Tuguegarao City Government for the completion of the City Health Office and ten (10) Barangay Health Stations;

WHEREAS, the actual fund to be released to the Tuguegarao City Government will be based on the bidded cost as a result of the public bidding conducted;

WHEREAS, the Tuguegarao City Government is willing to assist the DOH on the implementation of the project;

WHEREAS, the Tuguegarao City Government has the capacity and ability to implement the said project as signified in their letter-request to undertake the project by administration;


WHEREAS, the Tuguegarao City Government has submitted their previous liquidation report of the transferred expenditures and cleared of financial obligations.

NOW THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor, Atty. Jefferson P. Soriano, to enter, sign and execute for and in behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Health Regional Office No. 2, represented by Valeriano Jesus V. Lopez, M.D., MPH, CESO IV, for the implementation of CY 2014 Health Facilities Enhancement Program for the upgrading of Tuguegarao City Health Office and ten (10) Barangay Health Stations (BHS) which were included in the List of Funded Bottom-up Budgeting (BuB) Civil Work Projects..


