**WHEREAS**, Section 49 of Republic Act 9344 states that “each province and highly urbanized city (the LGUs) shall be responsible for building, funding and operating a ‘Bahay Pag-asa’ within their jurisdiction following the standards that will be set by the DSWD and adopted by the JJWC.”

**WHEREAS**, as the Regional Center and Provincial Capital, it is incumbent upon Tuguegarao City to establish and operate a suitable Temporary Shelter for Children in Conflict with the Law (CICL) and Violence Against Women and Children (VAWC);

**WHEREAS**, the Local Chief Executive, Hon. Atty. Jefferson P. Soriano, requested the Sixth City Council for a passage of a Resolution allowing the use of the 2<sup>nd</sup> Floor of the PNP Don Domingo PTU as the project site of the City for the Temporary Shelter of CICL and VAWC;

**NOW THEREFORE, RESOLVED**, as it is hereby **RESOLVED**, to allow the use of the Second Floor of the PNP Don Domingo for the Temporary Shelter for Children in Conflict with the Law (CICL) and Violence Against Women and Children (VAWC).
