CITY RESOLUTION NO. 146-2015

RESOLUTION APPROVING THE REQUEST OF MR. MELVIN P. VARGAS, PROPRIETOR, VARGAS ELECTRONIC BINGO GAMES, FOR A RESOLUTION OF NO OBJECTION (RONO), AS A PRE-REQUISITE OF THE PAGCOR IN THE ESTABLISHMENT AND OPERATION OF A GAMING AND AMUSEMENT BUSINESS (BINGO BOUTIQUE) AT BARANGAY LEONARDA, TUGUEGARAO CITY

WHEREAS, Mr. Melvin P. Vargas, Proprietor, Vargas Electronic Bingo Games, has applied to Philippine Amusement and Gaming Corporation (PAGCOR) for the establishment and operation of a Bingo Boutique in Barangay Leonarda, Tuguegarao City;

WHEREAS, the applicant, Mr. Melvin P. Vargas, requested for a Resolution of No Objection (RONO) from the Sanggunian concerned as part of the requirements of PAGCOR in the establishment and operation of a Bingo Boutique;

WHEREAS, the applicant has complied with the necessary documentary requirements, to wit:

- a. Contract of Lease;
- b. DTI Certificate of Business Name Registration;
- c. Special Power of Attorney of Mr. Enrique Melad to represent the applicant;
- d. Annual Personal Disclosure Statement;
- e. Certification of No Objection from the Barangay; and,
- f. Certification of the City Engineer that the location of the gaming and amusement business (Bingo Boutique) is not within the 200 meter radius from school and church premises

WHEREAS, the Committee on Games and Amusement conducted a public hearing on June 22, 2015 to solicit the sentiments/opinions of the residents of Barangay Leonarda, Tuguegarao City, relative to the operation of the Bingo Boutique in said Barangay;

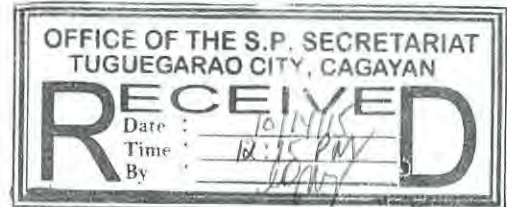
